### 2017 Legislative Update Now Available in the TexasBar CLE Online Classroom

Legislative changes from House Bill 7 and Senate Bill 999 affecting Texas Family Code Chapters 262 and 263 are also discussed, along with Attorney and Guardian Ad Litem duties under Chapter 107 and other relevant bills.
