CALL TO ORDER AND OPENING REMARKS

Justice Rebeca Huddle called the meeting to order at 9:55 a.m. and welcomed everyone to the September 2024 Children's Commission meeting. Justice Huddle expressed her gratitude to the Commissioners, Committee, and Collaborative Council members for their continuing partnership and engagement at Children's Commission meetings.

Commission, Committee, and Staff Member Changes

Justice Huddle announced that as the current Chair of the State Bar of Texas Child Protection Law Section, Hon. Bill Harris will serve as a Commissioner. She also shared that Ms. Luanne Southern is no longer at the Texas Child Mental Health Care Consortium but will continue to serve on the Commission as the Chief Behavioral Health Strategist at the Department of Family and Protective Services (DFPS). Ms. Katie Olse, previously with the Texas Alliance of Child and Family Services, left her role and will no longer serve on the Children's Commission. Ms. Madelyn Fletcher left her role at the Governor's Office and will no longer serve in an *ex officio* capacity. Justice Huddle expressed her thanks to these individuals for their significant contributions to the Commission.

Justice Huddle also announced that Ms. Natalie Taylor left her role as Director of Permanency at DFPS State Office and will no longer serve on the Systems Improvement Committee. Texas CASA Data Manager Mr. Sub Uppaluri joined the Data Committee.

Lastly, Justice Huddle reported that Mr. Dylan Moench would soon leave his role as Director of Legal Representation at the Children's Commission. He accepted a position as Chief Counsel at the Travis County Office of Child Representation. Justice Huddle expressed her gratitude for Mr. Moench's many contributions during his nearly eight-year tenure and for his enduring legacy at the Children's Commission.

During the meeting, outgoing Commissioner Hon. Selina Mireles and Mr. Moench were honored with certificates of service and acknowledged for their leadership and vision during their tenure with the Children's Commission.

Adoption of May 17, 2024 Meeting Minutes

Justice Huddle directed members to the May 17, 2024 Commission Meeting Minutes behind Tab 2 of the Meeting Notebook, distributed in advance of the meeting.

ACTION: Justice Huddle asked if there were any questions or edits to the minutes as written. Hearing none, after a motion and a second the Commissioners voted to adopt the minutes for the May 17, 2024 Children's Commission meeting.

TEXAS DEPARTMENT OF FAMILY & PROTECTIVE SERVICES (DFPS) UPDATE

Dr. Brock Boudreau expressed his gratitude for the partnership between the Children's Commission and DFPS, which supports the positive safety, permanency, and well-being outcomes for children in Texas. Dr. Boudreau reported that the federal Children and Family Services Review (CFSR) evaluates the functioning of the child welfare system through identified outcomes and systemic factors. Once the final CFSR report is received, DFPS will have 90 days to respond and initiate the development of a Program Improvement Plan (PIP). Dr. Boudreau commended the legal/judicial involvement with the CFSR process, especially in the area of case review and engaging stakeholders; he noted that Texas is a national model.

Dr. Boudreau shared that DFPS Commissioner Stephanie Muth is hiring additional staff to address children without placement (CWOP) efforts. DFPS will focus on ensuring that the new staff have the support and resources they need to work with children in need of placement. He also highlighted the agency's work on Texas Child-Centered Care (T3C) as an improved mechanism to assess individualized service needs. T3C will replace the service level system and update the service array and rate methodology.

Finally, Dr. Boudreau reported that the number of CWOP decreased dramatically since 2020. He shared that Associate Commissioner for Child Protective Services Ms. Erica Bañuelos implemented new solutions to reduce the number of CWOP from 50-60 to 10 children by conducting daily meetings to address each child's specific needs. Dr. Boudreau shared that DFPS also implemented new measures to prevent CWOP experiences for children and youth in care.

CHILDREN'S COMMISSION UPDATE

Ms. Jamie Bernstein directed members to the Report to the Commission behind Tab 3 in the Meeting Notebook for updates on FY24 projects. She expressed her gratitude to everyone who provided feedback about the slate of projects and activities for FY25 and referenced a related PowerPoint that is available on the Children's Commission website. The Children's Commission then laid out the key strategies that are new or updated in the coming fiscal year. The other strategies that were not addressed during the presentation remain unchanged from FY24.

For the Collaboration Goal in the Strategic Plan, Ms. Bernstein noted that the Commission's website will be updated in the coming fiscal year and invited future input regarding content and functionality. Ms. Bernstein also reported that CFSR Round 4 includes increased emphasis on legal and judicial involvement. During this process, the commission will likely partner with DFPS to develop pilots related to caregiver engagement and termination of parental rights.

For the Systems Improvement Goal in the Strategic Plan, Ms. Aimee Corbin announced that the commission recently initiated the Consortium for Trauma Informed Court Practices. The consortium is designed to be an informal space for judicial discussion and education focused on trauma-informed and trauma-responsive court practices. Ms. Corbin also reported that DFPS and

the commission partnered to educate the legal community and other child welfare professionals on the Texas Family First (TFF) pilot and on the law regarding reasonable efforts. These trainings will continue throughout every region of Texas. Ms. Corbin added that the commission, with the assistance of Education Reach for Texans, also plans to update the Higher Education Foster Care Liaison Guide. Ms. Bernstein shared that she would continue to serve on the Partners for Children and Families Committee (PCFC) which is an advisory body to DFPS on Community-Based Care. The Commission will also support the legal community in the continued expansion of CBC through regional trainings, including one in the Rio Grande Valley this winter. Lastly, Ms. Bernstein reported that the Juvenile Justice Committee was created in FY24 and that the Commission requested support from the Legislature to develop resources and training on juvenile justice issues.

For the Legal Practice & Process Goal in the Strategic Plan, Mr. Moench shared that the Legal Representation Committee plans to focus on pre-petition legal representation programs in FY25. Ms. Renée Castillo-De La Cruz announced that the DFPS Representation Subcommittee will help design the child welfare track at the Texas District and County Attorney Association's biennial Prosecuting Crimes Against Children Conference. She also shared that release of the Pre-Litigation Guide will occur after the 89th Legislative Session to ensure that the resource contains the most up-to-date information. Additionally, the Parent Resource Workgroup will update the Parent Resource Guide and develop a parent voice videos project. Mr. Moench shared that the Mediation Workgroup plans to finalize mediation-related checklists for attorneys and mediators and create webinar content on topics such as nonparty participation in child welfare mediations and special considerations for mediations involving incarcerated parents.

For the Training Goal in the Strategic Plan, Ms. Castillo-De la Cruz announced that the Trial Skills Training (TST) Contested Hearing Practices Pilot would take place in September 2024 in Dallas. The commission plans to further develop and hone this pilot in FY2025. Additionally, some of the TST lectures will be offered as webinars so that attorneys throughout the state have access to training related to courtroom practices. Ms. Castillo-De La Cruz reported that the Assistance to Local Jurisdictions is now included as a training strategy. Assistance to Local Jurisdictions support could extend to planning, financial, MCLE, and/or other support needed for local jurisdictions to provide training on child welfare related matters. Ms. Milbrey Raney discussed plans to offer general judicial scholarship funds to reimburse conference registration fees for judges who need financial support to attend recognized state and national trainings on child welfare matters. Ms. Raney also announced that the Commission will also expand educational offerings through a podcast series called "Children's Commission Conversations."

For the Data Goal in the Strategic Plan, Mr. Moench reported that the Data Committee will meet on October 25, 2024, to review how members can use the Child Protection Case Management System (CPCMS) and other data sources to enhance existing Children's Commission projects. He also shared that there will be a data presentation at the annual Child Welfare Judges Conference that will address key topics of safety, permanency, and well-being outcomes at the statewide level. Additionally, the CPCMS Advisory Council will continue to meet quarterly to discuss enhancements to the system.

Mr. Patrick Passmore directed members to the Financial Report and Grant Summaries behind Tab 4 of the Meeting Notebook and outlined the anticipated expenditures for the proposed FY25 projects.

ACTION: After discussion, Justice Huddle asked for a motion to approve the projects and associated expenditures. After a motion and a second, the Commissioners voted to approve the FY25 Strategies and Budget.

SPECIAL PRESENTATION ON DATA TRENDS

Justice Debra Lehrmann welcomed the following staff from DFPS: Ms. Sierra Fisher, Director of Analytics for Change and Enhancement, and Ms. Jennifer Sims, Deputy Commissioner of Operations. Discussion centered around the recently released DFPS Quarterly Data Report. The presentation is available on the Children's Commission website.

LEGISLATION & POLICY RESCOURCE COMMITTEE PRESENTATION

Justice Lehrmann shared that the Children's Commission recently created the Legislation and Policy Resource Committee (LPRC). Mr. Moench provided an overview of the committee's work. Mr. Moench shared that Commission staff presented the LPRC's eight legislative recommendations to the Texas Judicial Council's Civil Justice Committee on September 9, 2024. Following the presentation, Commissioners discussed the LPRC recommendations. After discussion, the recommendation related to least restrictive setting will be reconsidered before being presented at the Texas Judicial Council meeting in late September. The presentation is available on the Children's Commission website.

OFFICE OF COURT ADMINISTRATION (OCA) UPDATE

Mr. Jeffrey Tsunekawa introduced Mr. Marcus Crosby, the new Children's Court Program Manager at OCA. Mr. Tsunekawa then reported that OCA completed their Legislative Appropriations Request which includes funding for "docket rangers" to assist clerk's offices with new data reporting practices and requirements; a raise for children's courts court coordinators; TIDC's request to fund expansion of public defense offices and the Family Protection Representation Project; and a case management system for specialty courts. Mr. Tsunekawa also shared that OCA is implementing HB 1182 (88th Leg. Session), which requires reporting on case-level data such as the numbers of cases assigned, cases cleared, number of pleas, and cases tried before visiting judges in the seven areas with a population over one million. He noted that OCA is also focused on implementation of HB 2384 (88th Leg. Session) that requires case level data for every court (regardless of population) including the clearance rate information, average time from filing to disposition of a case, and the age of the active caseload.

Mr. Tsunekawa announced that OCA staff were actively engaged with launching the new Texas Business Courts and 15th Court of Appeals. Both new courts went into operation on September 1, 2024. The 15th Court of Appeals is located in Austin, Texas and there are currently 5 operating business courts around the state with the goal of reaching 11 total. He also shared that OCA is finalizing the court and clerks staffing study in partnership with Texas A&M University. This

report is due on December 1, 2024, and will address the staffing needs and the appropriate salary needed for court staff.

Mr. Tsunekawa also shared that OCA recently contracted with eCourtDate for the text reminder program. This program will be free for any court to use and will be set up within the next 4-6 weeks. Lastly, Mr. Tsunekawa announced that the Texas Judicial Council meeting will be accessible via YouTube on September 27, 2024, for those who are interested. All committees will submit their recommendations during this meeting.

COLLABORATIVE COUNCIL MEMBER UPDATES

Ms. Sarah Worthington shared that the Texas Foster Youth Justice Project received a grant from the Texas Access to Justice Foundation that allowed them to hire two new project attorneys, a paralegal, and a project manager. Additionally, Ms. Worthington guided Commissioners to the flyer included behind Tab 5 in the Meeting Notebook with details about the availability of free drivers' education classes for youth in foster care and youth who aged out of care. She added that driving schools must be registered with the Texas Workforce Commission to be eligible.

NEW BUSINESS

Justice Lehrmann announced that the last Children's Commission Meeting of the year will be held virtually on November 15, 2024. The 2025 Commission Meeting schedule is as follows:

Children's Commission FY 25 Strategic Plan

GOAL I (COLLABORATION)

Administer the Court Improvement Program (CIP) funds to assess current and future needs of the courts, provide a forum for meaningful collaboration, encourage continuous quality improvement, and promote best child welfare and court practices to improve the child welfare system.

- Strategy: Provide regular updates to the Children's Commission and the Systems Improvement, Legal Practice & Process, Training, and Data Committees about Commission initiatives.
- 2. <u>Strategy: Engage with the Collaborative Council and participate in and provide forums and opportunities for child welfare stakeholders to partner and to share information about child welfare practices, policies, needs, and strengths.</u>
- 3. Strategy: Develop, maintain, and enhance usability and function of the Children's Commission website, social media, print and online materials, and other communication mediums.
- 4. <u>Strategy: Confer with the Department of Family and Protective Services (DFPS) on the Child and Family Service Reviews, Program Improvement Plans, Child and Family State Plans, and the Court Improvement Program Strategic Plans.</u>

GOAL II (SYSTEMS IMPROVEMENT)

Execute innovative projects aimed at ensuring equity, fairness, and justice for children, youth, and families; promoting judicial leadership in courts and communities; and expanding court and child welfare system capacity to support continuous, systemic improvement.

- 5. <u>Strategy: Utilize Jurists in Residence to promote best practices to the judiciary and support the legal and child welfare systems through judicial leadership and expertise.</u>
- 6. Strategy: Engage stakeholders in the child welfare, juvenile justice, and mental health systems to apply principles of trauma-informed care and address gaps in services for children, youth, and families with complex mental health needs.
- 7. <u>Strategy: Identify and promote data-driven, cross-disciplinary opportunities to address disproportionality and disparities among children, youth, and families involved in child welfare cases.</u>
- 8. Strategy: Emphasize the importance of engaging children and youth in the case planning and court process as well as promote normalcy and the inclusion of young adults with lived experience in statewide system improvement efforts.
- 9. Strategy: Engage judges and lawyers in systemic efforts to prevent child abuse and neglect and address occurrences of child abuse and neglect while maintaining family preservation.

FY 25 Strategic Plan

- 10. <u>Strategy: Identify opportunities to develop sustainable partnerships between legal, child welfare, and education stakeholders in an effort to identify and address the educational needs and goals of children and youth who experience foster care.</u>
- 11. <u>Strategy: Partner with national, state, and local leaders to better support children, youth, and families with specialized needs such as addressing sexual abuse and complex medical cases.</u>
- 12. <u>Strategy: Work with DFPS and other child welfare stakeholders to identify critical and urgent topics for Round Table discussions and hold Round Table events as needed.</u>
- 13. <u>Strategy: Engage stakeholders in the legal system in statewide efforts to develop and expand placement capacity, including kinship care and the rollout of Community Based Care.</u>
- 14. <u>Strategy: Prioritize areas in need of improvement in the handling of juvenile justice cases as well as recommendations developed by the Dual Status Task Force.</u>

GOAL III (LEGAL PRACTICE & PROCESS)

Assist trial and appellate courts, judges, and legal advocates to ensure that children, youth, and families involved with child welfare experience a legal system in which they have access to justice and their rights are protected.

- 15. <u>Strategy: Convene and support a Legal Representation Committee to sustain efforts to ensure high-quality legal representation for parents, children, and DFPS.</u>
- 16. <u>Strategy: Support development and adoption of Standards of Representation for attorneys representing parents, children, and DFPS in child welfare cases.</u>

- 20. <u>Strategy: Establish and support meaningful relationships with federally recognized Tribes and promote awareness, education, and application of the Indian Child Welfare Act (ICWA).</u>
- 21. Strategy: Maintain a comprehensive Bench Book for judges hearing child welfare cases.
- 22. <u>Strategy: Maintain tool kits for attorneys representing parents, children, and DFPS in child welfare cases.</u>
- 23. <u>Strategy: Support increased child and family engagement through the use of technology, including the use of the Office of Court Administration (OCA) Notice and Engagement tool.</u>
